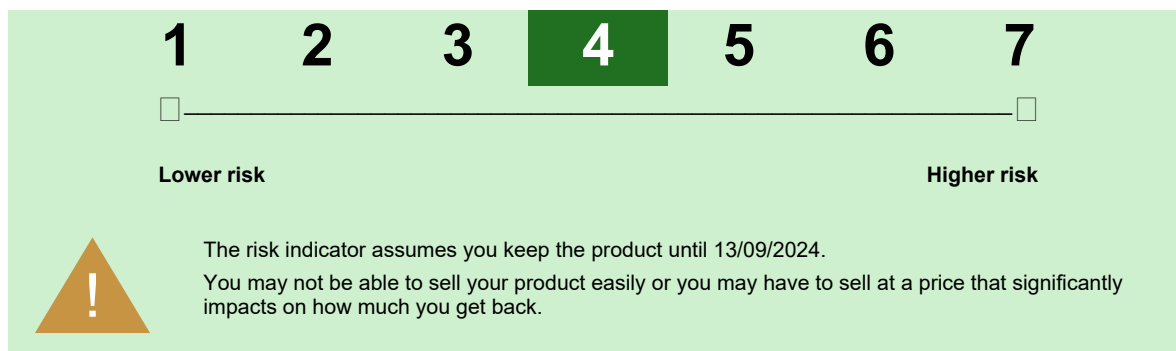

Intended Retail Investor The product C2109GRTIE is aimed at retail clients, who are interested in capital growth.
