

What is this product?

Objectives	A swaption is a binding agreement where you pay an amount (option premium) on the premium payment date to SEB for the right to enter into an interest rate swap with SEB according to defined terms. This right is exercisable on a future date (exercise date). Given that the holder of the option gives proper notice, the issuer is obliged to pay the value of the underlying swap.					
	The underlying swap serves the purpose of defining a possible future value of settlement for the swaption. The cash settlement will be close to the value of an actual swap entered into under the same conditions.

What are the risks and what could I get in return?



You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of SEB to pay you.

The scenarios illustrate how investments could perform. How long should I hold it and can I take money out early?

Recommended holding period: 6 years

Recommended holding period: This product is designed to be held to the agreed maturity date in order to match your investment requirement. You may not be able to cash in early, and you may have to pay significant extra costs to cash in early. It is a product to be entered into for its

term that cannot be easily sold. Early termination may occur (i) if certain events of default or other termination events occur or (ii) at the sole discretion of SEB, in which case early termination payments may apply.

Early exit impact: If the product is terminated early, in whole or in part, an Early Termination Payment may become payable by SEB. The Early Termination Payment is linked to market parameters and could be a substantial loss or gain to you. Settlement on early termination will be specific to your Swaption and will be influenced by a number of factors which include but are not limited to: whether it is an increasing or decreasing interest rate environment; the movement of the interest rates since the trade date; the amount affected by the early termination; general market conditions.

The Early Termination Payment is not a penalty charge. The sum represents the economic value of what SEB would have paid if the product continued as agreed.
