You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type	An Over the Counter (OTC) contract – Foreign Exchange Instrument
Term	The maturity date of the product will be agreed upon when entering into the contract, with no chance of early termination. There is no provision for early termination in the bilateral contract agreed between us, either by you or SEB.
Objectives	<p>The client as the seller of an Average Rate Put option acquires the obligation to buy a quantity of the Base Currency (notional amount) at a pre-agreed date (settlement date) at a pre-defined price (strike price). In return, the client receives an option premium on the premium payment date. This Average rate put option is exercisable by SEB at the end of the trade tenor (expiry date). The Average rate put option is cash-settled, and the settlement amount is based on the difference between the arithmetic average value of a pre-defined number of fixings of the spot rate of the Base Currency and the strike price. The average value of the spot rate of the Base Currency (FX spot rate) is calculated by the calculation agent.</p> <p>If the average value of the FX spot rate is fixed below the agreed strike price and SEB exercises the option, the client will pay the cash settlement which is calculated as the difference between strike price and the average value of the FX spot rate, multiplied by the notional amount.</p> <p>If the average value of the FX spot rate is fixed at or above the agreed strike price, the client will not pay a cash settlement.</p>

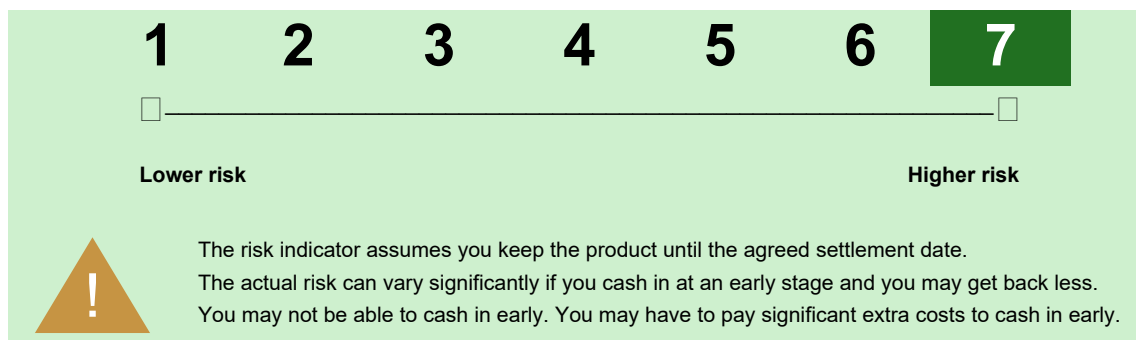

The Average Rate Put Option (Asian Option) is a product for advanced investors with good knowledge and/or experience with financial products. The investor is able to bear losses up to 100% of the invested amount and puts moderate emphasis on capital protection. On a scale of risk ranging from 1 (security-oriented; very low to low return) to 7 (very high risk tolerance; highest return) the product Average Rate Put Option (Asian Option) falls in risk category 7.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of SEB to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The scenarios illustrate how investments could perform. How long should I hold it and can I take money out early?

Recommended holding period: 6 months

Recommended holding period: This product is designed to be held to the agreed settlement date in order to match your investment requirement.

You may not be able to cash in early, and you may have to pay significant extra costs to cash in early. It is a product to be entered into for its term that cannot be easily sold. Early termination may occur (i) if certain events of default or other termination events occur or (ii) at the sole discretion of SEB, in which case early termination payments may apply.

Early exit impact: If the product is terminated early, in whole or in part, an Early Termination Payment may become payable by you. The Early Termination Payment is linked to market parameters and could be a substantial loss or gain to you. Settlement on early termination will be specific to your Average Rate Put Option (Asian Option) and will be influenced by a number of factors which include but are not limited to: whether it is an increasing or decreasing foreign exchange environment; the movement of the FX Spot Rate since the trade date; the amount affected by the early termination; general market conditions.

The Early Termination Payment is not a penalty charge. The sum represents the economic value of what you would have paid if the product continued as agreed.
