

The scenarios illustrate how investments could perform. How long should I hold it and can I take money out early?

Recommended holding period: 6 months

Recommended holding period: This product is designed to be held to the agreed settlement date in order to match your investment requirement. You may not be able to cash in early, and you may have to pay significant extra costs to cash in early. It is a product to be entered into for its

term that cannot be easily sold. Early termination may occur (i) if certain events of default or other termination events occur or (ii) at the sole discretion of SEB, in which case early termination payments may apply.
