What is this product?

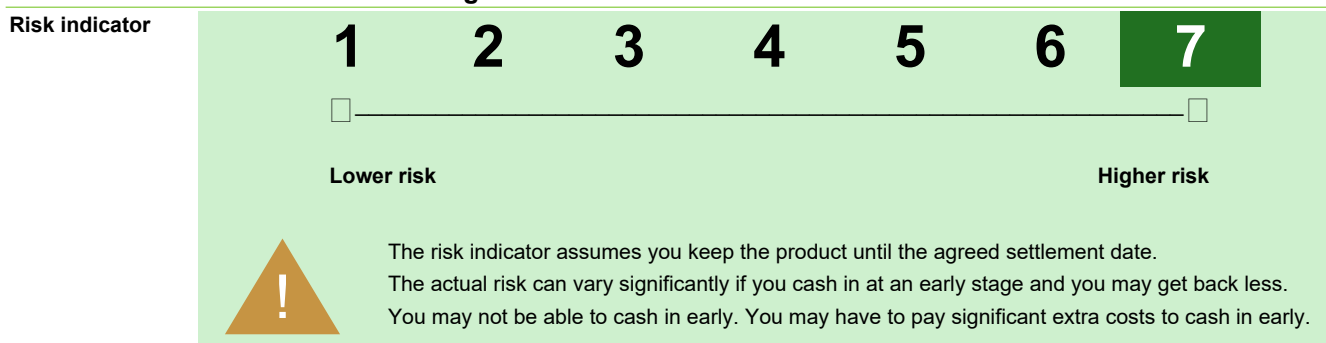
Type	An Over the Counter (OTC) contract – Foreign Exchange Instrument
Term	If the pre-determined Upper Barrier of 1.1344 or the Lower Barrier of 1.0264 is traded during the lifetime of the option, no payout will be made and the option is terminated. The OneTouch option is a bilateral agreement that cannot be ordinarily terminated unilaterally neither by you nor by SEB. This product has an expiry date of 29/10/2024.
Objectives	<p>Double No Touch options are binding agreements that give an investor a payout if the price of the underlying asset does not reach one of two pre-determined barrier levels.</p> <p>The client as the seller of a Double No Touch option will have an obligation to pay a pre-defined amount of money (payout) under the condition that none of the pre-determined barriers are traded. In return, the client receives an option premium on the premium payment date.</p> <p>If none of the barriers are traded during the lifetime of the option, the client will pay the payout to SEB.</p> <p>If one of the barriers is traded during the period of the option, no payout will be made.</p>

Intended Retail Investor	The product Double No Touch is aimed at retail clients, who are interested in hedging and leveraged participation. The Double No Touch is a product for advanced investors with good knowledge and/or experience with financial products. The investor is able to bear losses up to 100% of the invested amount and puts moderate emphasis on capital protection. On a scale of risk ranging from 1 (security-oriented; very low to low return) to 7 (very high risk tolerance; highest return) the product Double No Touch falls in risk category 7.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of SEB to pay you.

The scenarios illustrate how investments could perform. How long should I hold it and can I take money out early?

Recommended holding period: 6 months

Recommended holding period: This product is designed to be held to the agreed settlement date in order to match your investment requirement.

You may not be able to cash in early, and you may have to pay significant extra costs to cash in early. It is a product to be entered into for its term that cannot be easily sold. Early termination may occur (i) if certain events of default or other termination events occur or (ii) at the sole discretion of SEB, in which case early termination payments may apply.

Early exit impact: If the product is terminated early, in whole or in part, an Early Termination Payment may become payable by you. The Early Termination Payment is linked to market parameters and could be a substantial loss or gain to you. Settlement on early termination will be specific to your Double No Touch and will be influenced by a number of factors which include but are not limited to: whether it is an increasing or decreasing foreign exchange environment; the movement of the FX Spot Rate since the trade date; the amount affected by the early termination; general market conditions.
