You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type	An Over the Counter (OTC) contract – Foreign Exchange Instrument
Term	If the pre-defined knock-out level of 1.2409 has been traded during the lifetime of the option, the option will be terminated automatically. The Single Barrier Knock Out Call option is a bilateral agreement that cannot be ordinarily terminated unilaterally neither by you nor by SEB. This product has an expiry date of 12/09/2024.
Objectives	<p>Single Barrier Knock Out Call options are binding agreements that can be described as an option with built-in mechanism to expire worthless if a specified level has been traded.</p> <p>The client as the buyer of a Single Barrier Knock-Out Call option acquires the right to buy a quantity of the Base Currency (notional amount) at a pre-agreed date (settlement date) at a pre-defined price (strike price), under the condition that the pre-defined knock-out level is not traded at the end of the trade tenor (expiry date). In return, the client pays an option premium on the premium payment date.</p> <p>This Single Barrier Knock-Out Call option is exercisable by the client at the expiry date, if the spot rate for the Base Currency (FX spot rate) does not trade at or above the pre-defined knock-out level at the expiry. If the level is not triggered the client will have the right to exercise the option and buy the Base Currency and sell the Price Currency at the strike price for the notional amount.</p>

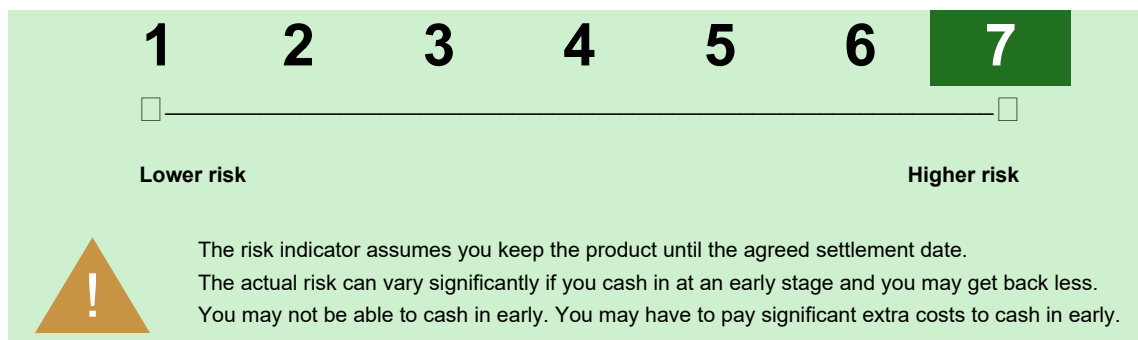

The Single Barrier Knock-Out Call Option (European Style) is a product for advanced investors with good knowledge and/or experience with financial products. The investor is able to bear losses beyond the invested amount and puts no emphasis on capital protection. On a scale of risk ranging from 1 (security-oriented; very low to low return) to 7 (very high risk tolerance; highest return) the product Single Barrier Knock-Out Call Option (European Style) falls in risk category 7.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. We classify all OTC derivatives as being of the highest risk class. This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of SEB to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The scenarios illustrate how investments could perform. How long should I hold it and can I take money out early?

Recommended holding period: 6 months

Recommended holding period: This product is designed to be held to the agreed settlement date in order to match your investment requirement.

You may not be able to cash in early, and you may have to pay significant extra costs to cash in early. It is a product to be entered into for its term that cannot be easily sold. Early termination may occur (i) if certain events of default or other termination events occur or (ii) at the sole discretion of SEB, in which case early termination payments may apply.

Early exit impact: If the product is terminated early, in whole or in part, an Early Termination Payment may become payable by SEB. The Early Termination Payment is linked to market parameters and could be a substantial loss or gain to you. Settlement on early termination will be specific to your Single Barrier Knock-Out Call Option (European Style) and will be influenced by a number of factors which include but are not limited to: whether it is an increasing or decreasing foreign exchange environment; the movement of the FX Spot Rate since the trade date; the amount affected by the early termination; general market conditions.
